The main objective of the School of Forestry is to give a professional education in forestry which will enable graduates to manage forest land for the maximum return of timber and associated products. Another objective of the school and its faculty is to counsel students concerning their individual interest in the forestry curriculum. its options, and in the profession. This includes helping graduating students and undergraduates in finding employment in forest-related positions.

To begin with, the school has printed up and sent a booklet entitled "A Message to Employers and Personnel Managers" to many potential employers to tell them of the SFA School of Forestry and the qualifications of its students. The Sante Fe Railroad and the Boy Scouts of America are just two examples of recent replies to this booklet.

The school also maintains files of job opportunities and files for graduating seniors seeking employment as well as students seeking summer jobs. The School itself is a placement service for U.S. Forest Service summer work.

Another effort by the school in aiding its students has been periodic seminars entitled "How to get a job." These seminars have stressed the fact that obtaining a job is really up to the student himself. The school has no funds or legal responsibility in job recruitment. All its assistance is voluntary.

Dr. Baurence C. Walker, Dean of the School of Forestry, has outlined the obligations of the student seeking employment this way:

- Write perfect (no erasures) letters of application to desired employers (25 is not excessive)
- Take the U.S. Civil Service Commission Assembled Exam II.
- Take the U.S. Civil Service Commission unassembled III. exam for foresters, game managers, etc. IV. Attend "How to get a job" seminars


 - Use Society of American Foresters referral service (must be a member of S.A.P.)
- Attend Society of American Foresters, Texas Forestry VI. Association, etc., meetings to make contacts
- VII. Keep up grades and be active and cooperative to insure favorable school references

It was cited by Dr. Walker that approximately 85 percent of SFA graduates are now employed in forestry or other related jobs. When asked about the future, Dr. Walker said, "I believe that by this spring the national economy will be sufficiently stimulated to provide adequate employment opportunities for foresters in wood-using industries, government, and environmental organizations."
